FREE VIRTUAL WORKSHOP ON THE IMPORTANCE OF LEGAL PLANNING FROM THE MELVIN J. & CLAIRE LEVINE LIFEPLANNING[®] PROGRAM TO BE HELD ON WEDNESDAY, MARCH 31

WEST PALM BEACH, FL – March 2, 2021 – Ferd & Gladys Alpert Jewish Family Service (Alpert JFS) invites community members to attend "The Importance of Legal Planning," a free virtual workshop from the Melvin J. & Claire Levine LifePlanning[®] program on March 31, 2021 at 2:00 p.m.

Mitchell I. Kitroser, Esq., of Kitroser & Associates Attorneys at Law, will be the featured speaker. Topics will include special needs trusts, pooled trusts, guardianship, advance directives (Power of Attorney, and Health Care surrogate), and The ABLE Act.

"Caring for a loved one with a disability can be so all-consuming in-the-moment that people often put off talking about the future," said Director of LifePlanning[®] Tami Lustig, MSW. "Having a well-thought-out plan in place is very important when the time comes, and is one less thing to be concerned about.

"The use of trusts and incorporation of benefits as part of your overall plan should be part of your strategy," said Kitroser. "Join us to learn about the legal aspects from my presentation.'

Topics in January and February were Social Security Disability Insurance (SSDI) and Social Security Insurance, and Assistive Technology Tools, respectively.
