VIRTUAL TECHNOLOGY ENABLES CAREGIVERS OF THE DISABLED TO PARTICIPATE IN FREE LEGAL WORKSHOP THROUGH THE MELVIN J. & CLAIRE LEVINE LIFEPLANNING™ PROGRAM

WEST PALM BEACH, FL – April 2, 2020 – Twenty-five people who care for individuals with disabilities of all kinds came together on Wednesday, April 1, 2020 for a videoconference, with Mitchell A. Kitroser, Esq., to participate in a "Legal Planning for the Future" workshop. The Melvin J. & Claire Levine LifePlanning™ program, which is part of the Ferd & Gladys Alpert Jewish Family Service's (Alpert JFS) Jewish Disabilities Network (JDN), hosted the free program.

Topics included special needs trusts, pooled, trusts, guardianship, advanced directives (Power of Attorney and Health Care Surrogate), and the ABLE Act (the acronym for A Better Life Experience), that gives families tax-free savings to care for their loved ones with a disability, who qualify, without losing federal benefits. Closed captioning was available for hearing-impaired participants.

Mr. Kitroser is the founder and managing attorney of Kitroser & Associates, a law firm focusing on guardianship, elder law, wills, trusts, probate, trust administration, Medicaid planning, and special needs planning.

"This virtual legal planning workshop gave attendees the opportunity to learn about the importance of getting documents in order, and also expanded their horizons technologically, "said Tami Lustig, MSW.
