A Message from Our CEO

Dear Neighbors and Friends,

It is with immense gratitude and pride that I write to you today, reflecting on our agency's remarkable achievements of the past year. I am pleased to report that our agency has continued to thrive and have a profound impact on the lives of individuals and families in our community. The unwavering commitment of our dedicated staff, generous donors, and caring volunteers have been instrumental in our success, and I cannot thank you all enough.

Below are just a few examples of our agency's life-changing impact this past year.

- In response to the growing human service needs in our community, we significantly expanded our services to provide support to even more individuals and families over 12,000 people this past year.
- We expanded our food distribution efforts and collaborated with local partners to provide nutritious meals to those in need. We recently added a dedicated care manager to our food insecurity team. Our program now offers over 150 clients personalized attention, connecting them with financial services, career counseling and behavioral health services.
- We have forged strategic partnerships with other local organizations, government agencies, and businesses, amplifying our impact and extending our reach to those who need our services the most. In the past two years we secured a total of \$1,025,000 in Federal earmarks for the construction of our Enrichment Center in Boynton Beach, thanks to the tireless efforts of Congresswoman Lois Frankel. We also secured an \$825,000 Federal earmark for the buildout of our new Center for Belonging and Wellbeing in Palm Beach Gardens that was sponsored by Congressman Brian Mast. These two beautiful new facilities will position us to meet the growing needs of our community far into the future.
- Our commitment to fostering a sense of belonging within our community has never been stronger. We hosted a variety of events and educational programs, bringing our community closer together and promoting understanding and unity, including our second annual Holocaust Survivor Day celebration and inaugural Recovery Seder.

As we look to the future, we are excited about the opportunities and challenges that lie ahead. In 2024 we will be celebrating our agency's 50th anniversary. We remain committed to our vision of creating a community where everyone can lead a fulfilling life, and we are confident that, together with your ongoing support, we will achieve even greater milestones in the years to come. 



JFS Psychologist Helps Young Mother Overcome Mental Health Challenges

Sarah is a 34-year-old woman who embarked on a transformative journey when she started therapy with Alpert JFS in 2016. Sarah's life was plagued by erratic moods and unstable relationships, leaving her estranged from her mother and her year-old son at the time. The gravity of her struggles became evident when she found herself hospitalized due to suicidal ideation.

Sarah's psychologist employed a compassionate and supportive approach, skillfully utilizing cognitive behavioral therapy (CBT) and dialectical behavior therapy (DBT) techniques to address Sarah's mood instability and unhealthy relationships, particularly with her mother and son. Over several years, Sarah's psychologist demonstrated what a healthy relationship entails. Through consistent support and guidance, Sarah gradually reconnected with her mother and son, cultivating healthy patterns of communication and a safe space to express their feelings. It was truly heartening to witness the healing that took place within their family unit.

As Sarah's therapy progressed, so did her personal growth. Today she resides with her mother and son in a loving and supportive environment—a testament to her immense progress since starting therapy. In addition to rebuilding familial bonds, Sarah also secured a new job. Equipped with the skills she learned in therapy, Sarah has fostered healthy relationships with those around her, extending beyond her immediate family.

We hope Sarah's journey serves as a beacon of hope to others who are struggling with mental health challenges. Thanks to the support of Alpert JFS, Sarah has gone on to have a life of stability, safety, and good health.

JFS Food Pantry Helps Family Regain Financial Footing

Before the pandemic, Cheryl and Dan had good jobs in the hospitality industry. Together with their two children, they enjoyed very stable and comfortable lives. In 2020, all of that changed. With meetings and functions canceled, their employers downsized, leaving Cheryl and Dan out of work. The lack of a steady income took a toll on their family. Thankfully, in 2023 Cheryl and Dan found new jobs, although their salaries have not fully recovered. With inflation, rising fuel costs, and tuition increases at their children's day school, feeding their family became a challenge.

Reluctantly, Cheryl and Dan contacted Alpert JFS for help, which greatly embarrassed them. They were always the family that delivered groceries to seniors and Holocaust survivors. It never crossed their minds that one day they would be the ones in need.



Thanks to our caring Food Pantry staff and volunteers who treated them with dignity, Cheryl and Dan were able to move beyond the discomfort of receiving food assistance. Instead, they focused on regaining their financial footing. Today they are on the road back to a stable life with their two children. "I don't know how we would have managed without the Alpert JFS Food Pantry. Not only were we able to supplement our food budget, but the kindness and compassion of the staff helped ease our stress."



Rochelle is a 65-year-old woman who has been receiving services from Alpert JFS for nearly 15 years. She has limited family and social support, and minimal finances. A JFS care manager was assigned to Rochelle to identify her physical, emotional, and social needs, and develop a comprehensive care plan. In addition to care management services, today Rochelle also receives psychiatry, counseling, friendly visitor and food pantry services, as well as Meals on Wheels and chore services.

Rochelle has had a history of falls, including three falls in the past few months. Her most recent fall occurred in January, and she was hospitalized for a week, followed by a stay in rehab. Her care manager advocated for Rochelle to ensure she received the care she needed to prevent further falls. Rochelle's care manager also worked with Rochelle to address the barriers to her independence so she could return home.

JFS Helps Senior Regain Her Independence

Discharged from rehab, Rochelle has been living at home for several weeks. Rochelle's care manager continues working with her to help her stay safe and independent at home. Her care manager arranged for home health services, including a registered nurse for diabetic teaching and a home health aide to provide support with transportation, grocery shopping, meal preparation, housekeeping, and bathing.

Rochelle's care manager is an invaluable resource, providing Rochelle with the care and support she needs to live a safe and independent life. Rochelle has resumed driving and volunteering for the foster grandparenting program that she participated in before her hospitalization. Rochelle is happy to be home and resume her regular activities. It is so rewarding to see that she has returned to doing what she loves the most.





JFS is Strengthening Ties with Our Government Officials

Over the past four years, Alpert JFS has cultivated strong ties with government officials and other agencies, emerging as a leader in expanding mental health services for thousands in need of help. In the past year alone, we received over \$2,243,000 in government funding for our agency, including over \$718,000 in State appropriations. This is a result of our effective advocacy efforts, showcasing our exceptional work in meeting the needs of our clients and community. This new revenue stream is a huge boost to our agency's long-term sustainability and growth.

Over the past year, we worked closely with our elected officials to generate nearly \$2 million in state funding for Alpert JFS for 2023-2024, allocated for Mental Health First Aid (MHFA). This funding will allow us to expand our training efforts beyond Palm Beach County, reaching Broward, Hillsborough, Manatee, Martin, Miami-Dade, Pasco, Pinellas, Polk, and St.




Lucie Counties. This expansion provides MHFA training to more individuals and communities, equipping them with the knowledge and skills to effectively identify and respond to mental health challenges.

U.S. Congresswoman Lois Frankel, JFS Board Member Ruth Naftly and David Naftly at the 19th Annual No Excuse for Abuse Evening. Thanks to the efforts of our legislative champions, the 2023 state budget included \$1.2 million in funding for mental health services in South Florida. For the second consecutive year this funding will support the Jewish Family Services Affordable Behavioral Health Collaboration—a partnership that includes Alpert JFS, Rales JFS, Goodman JFS, and Jewish Community Services of South Florida. Together, we will continue to provide accessible and quality mental health services to individuals and families in need across the region.

For the first time, at the invitation of Palm Beach County Mayor Gregg Weiss, Alpert JFS participated in Palm Beach County Legislative Days in Tallahassee, strengthening our impact and engaging over 200 elected officials and stakeholders.

Care and Support for our Holocaust **Survivors**

Nearly 80 years later, the trauma of the Holocaust is still alive in many survivors' hearts and minds. Victor was born in Leningrad, Russia. When he was a child, his family lived in hiding and nearly starved to death. During the Siege of Leningrad by the Nazis, Victor lost many family members. He was able to survive the war and escape to the United States. He is one of the over 250 Holocaust survivors that Alpert Jewish Family Service currently cares for.

Over the last five years, our Jewish Family Service agencies in Palm Beach County* have provided 1.172 local Holocaust survivors with:

Spent for in-home care, \$73 730 954 care management, financial assistance, medical and dental care and socialization.

- 3 240 223 Hours of in-home care.
 - **106 600** Hours of care management.

Why I Give: Lesley Sheinberg

The event has helped to reduce the stigmas surrounding domestic abuse and mental illness. And it has evolved to be a beacon of hope by Shining a Light on the agency's life-changing programs and services.

We continue to Shine a Light on domestic abuse, and for very good reason. Domestic abuse happens as frequently in Jewish homes as in the general community. We understand that silence too often surrounds other painful issues faced by families in our community – struggles with mental illness, the disease of addiction, and the heartache of suicide. And sadly, there are times when many of these issues occur simultaneously in a single household.

Unfortunately, over the past three years, the isolation, loss, and stress added by the pandemic have caused each of these issues to grow exponentially. So many people are struggling – too often alone. As a result, we have expanded our signature event to Shine a Light on all of these areas.

The event's lasting impact is a testament to the hard work and support of our co-chairs, committee members, sponsors, ambassadors and hosts. We are grateful for their help in making this year's event possible.

Expanding Our Horizons: Two New Centers to Serve Thousands More in Our Community

Last year we announced plans to significantly expand our reach with the development of two new facilities that will position us to meet the growing needs of our community far into the future. In 2023 we received a significant boost to our expansion plans through the federal spending bill signed by President Biden. The bill includes two earmarks that will provide an additional \$1,525,000 for the construction of these new facilities - the Alpert JFS Enrichment Center in Boynton Beach and the Center for Belonging and Wellbeing in Palm Beach Gardens. Scheduled to open in the fall of 2023, these two new locations will afford a growing population with increased access to supportive services. These facilities are an essential part of our overall plan to better position Alpert JFS to meet the continually evolving human service needs of our community and will help provide the visibility to attract a prospective client base that is growing and changing.

The Alpert JFS Enrichment Center will offer a holistic approach to wellness by placing an expanded food pantry, care management, emergency financial assistance, supportive, counseling, nutrition classes, career counseling and therapeutic socialization activities all under one roof. This dynamic combination of comprehensive services will allow our professional therapists and care managers to guide our clients toward security, self-sufficiency, and ultimately stability.

Our new Center for Belonging and Wellbeing will create an inclusive and supportive environment where all individuals can thrive and achieve their full potential. The Center will be the hub of social interaction for adults with disabilities in our Residential Program while also serving the broader community of those with disabilities who are not part of our supportive living program.

With the buildout of these two new locations, we envision a brighter future for our agency and the people we serve. These facilities will provide increased accessibility and will foster a sense of belonging and community, ensuring that no one is left behind.
